General Rules

1. Each level will last thirty (30) minutes, game will change every 6 hands regardless of how many players are seated at the table.
2. Players will start with 20,000 in tournament chips.
3. Players may buy-in and re-enter through the end of level 7 (Including Break). Players are permitted ONE Re-entry per event. Tournament Surrender is allowed on Level 7 break.
4. Twelve (12) minute breaks will be after level 4 and every 3 levels thereafter.
5. Payout structure based on number of entries and will be approximately 12.5% of field
6. \$50 of the \$470 Buy-In will be withheld for Entry Fee. \$20 of the \$470 will be withheld for Staff Fee. \$400 of each \$470 Buy-In will go to Prize Pool.
7. Tournament will be played 6 handed (Management reserves the right to play 7 handed until registration is closed and all players are seated) Final table will be 7 handed.
8. Management reserves the right to cancel or change tournaments.
9. Tournaments will use TDA rules.
10. Residents of foreign countries without a U.S. tax treaty will be subject to withholding.
11. All players must use their Player's Club Card to enter the tournament.
